### CANNABIS ADVISORY COMMITTEE TO HOLD VIRTUAL MEETING IN SEPTEMBER

SACRAMENTO – The Bureau of Cannabis Control (Bureau) announced today that the Cannabis Advisory Committee will hold a two-day virtual meeting on Thursday, September 24 and Friday, September 25, 2020. The focal point of the meeting will be to discuss and provide recommendations for consolidating the three licensing authorities regulations into one comprehensive set of regulations applicable to California’s cannabis industry.

The Cannabis Advisory Committee advises the Bureau, the California Department of Food and Agriculture, and the California Department of Public Health on the development of regulations that help protect public health and safety and do not perpetuate the illegal market for cannabis.
